



# 2023 COMPETITION LICENSE APPLICATION with 2023 ANNUAL EMERGENCY CONTACT FORM INSTRUCTIONS

**PRINT NEATLY.** Fill out all spaces on both the 2023 COMPETITION LICENSE APPLICATION and the 2023 ANNUAL EMERGENCY CONTACT FORM completely. It is important that you print clearly and precisely. **Incomplete or illegible applications will not be processed until all information has been received.**

- 1. Applicant information:** Alternate phone # is optional, all other information is required.
  - First time applicants must attach proof of age documentation
  - If under age 18 on date application is signed you must attach the separate MINOR RELEASE FORM which is available from the CMRA office or on the [LICENSE AND TEAM REGISTRATION FORMS](#) page of the website. **Both parent's or all guardian's signatures required on the MINOR RELEASE FORM, please contact the CMRA office if you have questions about this or any other requirement.**
  - **AMA Membership #:** AMA Membership is required for all CMRA Competition License holders. AMA membership can be purchased through <https://americanmotorcyclist.com/ama-event-membership-form?promoterCode=CEMORR>. Note: Jr Motard riders will be provided a complimentary Jr AMA membership when competing.
- 2. License Type:** Check one; riders wishing to move from Novice to Expert must include a letter justifying their request.
- 3. About Competition Numbers:** Riders wishing to retain their 2022 competition numbers must renew their license on or before the January 1, 2023 deadline. Applications must be received in the CMRA office on or before midnight January 1, 2023. Beginning January 2, 2023 all numbers which have not been renewed become available first come, first serve based on the date the application was received in the CMRA office. No exceptions. Numbers will not be assigned over the phone or without a license application. If you are requesting a new competition number, assignment information will not be available before January 7, 2023.
  - **RENEW 2022 CMRA COMPETITION LICENSE:** Complete this section **only** if you held a CMRA Competition License in 2022.
  - **NEW or RETURNING TO CMRA:** Complete this section **only** if you hold a license from another racing organization or held a CMRA Competition License prior to 2022. Racers from another racing organization must attach a copy of their last license from that organization.
  - **NEW RACER or RETURNING PROV NOV:** Complete this section **only** if you are a first-time racer and have completed an approved License School or are a returning CMRA Provisional Novice. First-time racers must attach a copy of their License School Certificate.
  - **COMPETITION NUMBER PREFERENCE:** Complete this section unless you elect to retain your 2022 CMRA number **and** your application is submitted timely to be received by the CMRA before midnight January 1, 2023. Numbers 1-10 are reserved for riders who earned them in 2022. Two-digit numbers are reserved for riders with **active sprint** Expert status only – see Rule Book Section 1.1.
- 4. READ THE RELEASE AND AGREEMENT.**
- 5. LICENSE FEE:** Check one box as appropriate.
  - "One Weekend" license may be used only once per season; One-Weekend fee will be applied toward a later annual license application fee.
  - You may apply for 10-year or 15-year Competition License at the start of your 11<sup>th</sup> or 16<sup>th</sup> year, respectively. If this is your first year to apply for the 10-year or 15-year Competition License option, you must attach proof of paid, **continuous** Competition License up through 2022 for the number of years checked; **this is required, no exceptions.**
- 6. PAYMENT METHOD:** "CVV2" refers to the 3 or 4-digit code on the back of your credit card and is required.
- 7. 2023 ANNUAL EMERGENCY CONTACT FORM:** **This form must be submitted with your License Application.** The CMRA will attempt to provide this form to emergency personnel if you are transported to a treatment facility. **One of the emergency contacts listed on this form should be a person authorized to make medical decisions on your behalf if you are unable to make those decisions yourself.**
- 8. Print the forms.** Use 'print to fit' setting, verify that all text is visible on your printed forms.
- 9. Sign and date the License Application and the Emergency Contact Form. 'Electronic' signatures are allowed.**

- Email attachments must be PDF format scans of the forms and must not be embedded in the body of the email; **photos (JPEG etc.) of forms are not acceptable and will be rejected**
- Note that email is not a secure method of transmitting credit card information.

**Checks and credit cards will not be deposited or charged until January 2, 2023.** Please be sure that your credit card info is current and has an available balance on January 2, 2023. Declined credit cards will cause your application to be moved out of line and into the pending folder until updated payment information has been received.

Your License Card can be picked up at the next race event after your application is submitted. **One parent or guardian who signed the MINOR RELEASE FORM must accompany minors when they pick up their License Card.**
