



ENDURANCE MACHINE 2023 TECHNICAL INSPECTION FORM INSTRUCTIONS

TO PRINT THIS FORM: Use 'print to FIT' setting, verify that all text is visible on your paper form.

This form may be completed on-screen using free [Adobe Acrobat Reader](#) or printed blank and completed by hand.

PRINT NEATLY. It is important that you print clearly and precisely.

INCOMPLETE OR ILLEGIBLE FORMS WILL NOT BE PROCESSED AND WILL RESULT IN NON-PAYMENT OF AWARDS.

- Complete One Tech Form per machine annually
- You must complete and submit this form even if not filing for any contingency

NOTICE

Many Contingency Providers require a separate form to be completed and submitted prior to your first race of the season and/or at each race of the season. It is **your responsibility** to become familiar with each Contingency Provider's requirements and submit any and all required forms **when you take your machine for tech inspection**. You may **not** submit any required Contingency Provider forms **after** the race to which they apply.

Contingency Provider information and forms are available on the CMRA website on the [Contingency Page](#) and in the Tech Inspection Area at each event – **ask** the Tech Inspector **before** taking your machine to the Tech Inspection Area if you have any questions whatsoever.

BEFORE going to the Tech Inspection Area:

- Review the CMRA Rule Book and ensure that your machine meets all applicable requirements.
- Remove all old tech stickers from your machine.
- Complete the form (**VIN is required**) above the Owner or Captain Signature and Date line.
- **READ THE RELEASE AND AGREEMENT.**
- Print the form, verify all text is visible / not clipped off at the margins, then sign and date the form. **'Electronic' signatures are allowed.**
- Complete any and all Contingency Provider forms required to be submitted at the event.

TAKE to the Tech Inspection Area:

- This completed form.
- All of your yellow-copy at track Entry Forms for the machine in being inspected (to ensure you get all required stickers).
- **Any and all** required completed Contingency Provider forms.
- Your machine.
- Your transponder does NOT have to be mounted on the machine but **your transponder mount must be installed.**

You may make multiple trips to the Tech Inspection Area if required to get all of your equipment inspected.

Only upon achieving FULL COMPLIANCE for all items, the tech Inspector will sign and retain your Contingency Provider forms, and affix a Tech Sticker to your machine and helmet as applicable.

DO NOT enter the track for any purpose on a machine which does not display the Tech Sticker for the event.
